After waiving his right to a hearing before the Board of Stewards, Perry W. Ouzts, who finished third aboard TAKE CHARGE D'ORO in the tenth race at Turfway Park on February 14, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Perry W. Ouzts is hereby fined two hundred fifty dollars (\$250.00) and suspended one Kentucky racing day, Friday, February 21, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
