**HISA
KENTUCKY STEWARDS RULING**

After a hearing before the Board of Stewards, Christopher Emigh, who finished fourth aboard **PEAK POPULARITY** in the eighth race at Turfway Park on February 14, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (2nd offense). Pursuant to HISA Rule 2282 (c)(1), Class 3, Christopher Emigh is hereby fined one thousand dollars (\$1,000.00) and suspended two Kentucky racing days, February 26, and February 27, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
