**HISA
KENTUCKY STEWARDS RULING**

After waiving his right to a hearing before the Board of Stewards, Constantino Roman, who finished first aboard GIRL OF MY DREAMS in the sixth race at Turfway Park on February 28, 2025, was found to have violated HISA Rule 2280 (c)(9) by striking his mount repeatedly with his goggles after dropping his riding crop in the stretch. Pursuant to HISA Rule 8200 (b), Constantino Roman is hereby fined five hundred (\$500.00) dollars. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
