**HISA
KENTUCKY STEWARDS RULING**

KY. Ruling number: HISA 25-025

Track: Turfway Park

After waiving his right to a hearing before the Board of Stewards, Laureano Sosa, who finished sixth aboard KATE WINS in the ninth race at Turfway Park on March 1, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (2nd offense). Pursuant to HISA Rule 2282 (c)(1), Class 3, Laureano Sosa is hereby fined five hundred dollars (\$500.00) and suspended two Kentucky racing days, March 14, and March 15, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
