**HISA
KENTUCKY STEWARDS RULING**

After waiving his right to a hearing before the Board of Stewards, Perry W. Ouzts, who finished second aboard SOPHISTICATED CAT in the sixth race at Turfway Park on March 14, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (2nd offense). Pursuant to HISA Rule 2282 (c)(1), Class 3, Perry W. Ouzts is hereby fined five hundred dollars (\$500.00) and suspended two Kentucky racing days, March 26 and March 27, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
