**HISA
KENTUCKY STEWARDS RULING**

After a hearing before the Board of Stewards, Alexander Bendezu, who finished first aboard SASSY WALKER in the eighth race at Turfway Park on March 20, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Alexander Bendezu is hereby fined two hundred fifty dollars (\$250.00) and suspended one Kentucky racing day, Friday, April 4, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
