HISA KENTUCKY STEWARDS RULING

After a hearing before the Board of Stewards, Adam Beschizza, who finished third aboard BACKTRACK in the fifth race at Turfway Park on March 27, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (4th offense in 180 days). Pursuant to HISA Rule 2282 (c)(1), Class 3, Adam Beschizza is hereby fined one thousand dollars (\$1000.00) and suspended four Kentucky racing days, April 10 through April 13, 2025 (inclusive). Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
