**HISA
KENTUCKY STEWARDS RULING**

After a hearing before the Board of Stewards, Adam Beschizza, who finished first aboard CABALLO FELIZ in the eighth race at Turfway Park on March 29, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (5th offense in 180 days). Pursuant to HISA Rule 2282 (c)(1), Class 3, Adam Beschizza is hereby fined one thousand two hundred fifty dollars (\$1250.00) and suspended five Kentucky racing days, April 16 through April 20, 2025 (inclusive). Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
