## HISA KENTUCKY STEWARDS RULING

After waiving his right to a hearing before the Board of Stewards, Arcelio Flaco, who finished seventh (last) aboard CODE OMAHA in the sixth race at Keeneland on April 12, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (2<sup>nd</sup> offense). Pursuant to HISA Rule 2283 (c)(1), Class 3, Arcelio Flacco is hereby fined one thousand dollars (\$1,000.00) and suspended two Kentucky racing days, April 18 and April 19, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
