**HISA
KENTUCKY STEWARDS RULING**

After being represented at a hearing before the Board of Stewards, Cristian A. Torres, who finished third aboard WE'LL DO IT LIVE in the eighth race at Keeneland on April 16, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (2nd offense). Pursuant to HISA Rule 2282 (c)(1), Class 3, Cristian A. Torres is hereby fined one thousand dollars (\$1,000.00) and suspended two Kentucky racing days, April 29 and April 30, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
