After waiving his right to a hearing before the Board of Stewards, Lanfranco Dettori, who finished second aboard LIMITED LIABILITY in the ninth race at Keeneland on April 19, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (2<sup>nd</sup> offense). Pursuant to HISA Rule 2282 (c)(1), Class 3, Lanfranco Dettori is hereby fined one thousand five hundred dollars (\$1,500.00) and suspended two Kentucky racing days, May 1 and May 2, 2025.

Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
