**HISA

After waiving his right to a hearing before the Board of Stewards, Edgar Morales, who finished third aboard BA DEE YAH in the seventh race at Churchill Downs on May 18, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Edgar Morales is hereby fined five hundred dollars (\$500.00) and suspended one Kentucky racing day, Friday, May 30, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
