After waiving his right to a hearing before the Board of Stewards, Joseph C. Bealmear, who finished fifth aboard LADY MERCEDES in the first race at Churchill Downs on May 26, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Joseph C. Bealmear is hereby fined two hundred fifty dollars (\$250.00) and suspended one Kentucky racing day, Sunday, June 1, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
