After a hearing before the Board of Stewards, James Graham, who finished first aboard DUKE OF SUGGINS in the third race at Churchill Downs on June 1, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, James Graham is hereby fined five hundred dollars (\$500.00) and suspended one Kentucky racing day, Wednesday, June 18, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
