After a hearing before the Board of Stewards, Antioco Murgia, who finished third aboard A P SWEETHEART in the first race at Churchill Downs on June 6, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (4th offense). Pursuant to HISA Rule 2282 (c)(1), Class 3, Antioco Murgia is hereby fined two thousand dollars (\$2,000.00) and suspended four Kentucky racing days, June 21, June 22, June 25 and June 26, 2025.

Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
