## HISA KENTUCKY STEWARDS RULING

**KY. Ruling number: 25-082**

**Track: Ellis Park**

**Date: July 26, 2025**

**Jockey: Jaime A. Torres (HISA #P000015294)**

After waiving his right to a hearing before the Board of Stewards, Jaime A. Torres, who finished second aboard UNDERCOVER AGENT in the fifth race at Ellis Park on July 20, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (3<sup>rd</sup> offense). Pursuant to HISA Rule 2282 (c)(1), Class 3, Jaime A. Torres is hereby fined one thousand five hundred dollars (\$1,500.00) and suspended three Kentucky racing days, August 11, August 16 and August 17, 2025.

Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
