HISA KENTUCKY STEWARDS RULING

KY. Ruling number: 25-083

Track: Ellis Park

Date: July 26, 2025

Jockey: Samuel Camacho, Jr. (HISA #P00008251)

After waiving his right to a hearing before the Board of Stewards, Samuel Camacho, Jr., who finished first aboard GOLDEN GLIDER in the fourth race at Ellis Park on July 20, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking his mount eight times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Samuel Camacho, Jr. is hereby fined two hundred fifty dollars (\$250.00) and suspended one Kentucky racing day, Monday, July 28, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
