HISA KENTUCKY STEWARDS RULING

KY. Ruling number: 25-084

Track: Ellis Park

Date: August 9, 2025

Jockey: Brooke Stillion (HISA #P000024496)

After a hearing before the Board of Stewards, Brooke Stillion, who finished sixth aboard EL CHAVO in the first race at Ellis Park on August 4, 2025, was found to have violated HISA Rule 2280 (b)(2) by striking her mount nine times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Brooke Stillion is hereby fined two hundred fifty dollars (\$250.00) and suspended one Kentucky racing day, Saturday, August 16, 2025. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
