HISA KENTUCKY STEWARDS RULING

Pursuant to the Agreed Resolution of HISA Action 2026-00447 (Kentucky Stewards HISA ruling #26-021 issued March 6, 2026), Orlando Bocachica is hereby fined five hundred dollars (\$500.00) and suspended four Kentucky Racing days, March 25 through March 28, 2026 (inclusive), for violation of HISA Rule 2280 (b)(2).

The HISA Agreed Resolution requires payment of the imposed fine to the Horseracing Integrity and Safety Authority by April 12th, 2026.
