HISA KENTUCKY STEWARDS RULING

KY. Ruling number: 26-026

Track: Turfway Park

Date: March 21, 2026

Jockey: Christopher A. Emigh (HISA #P000009605)

After waiving his right a hearing before the Board of Stewards, Christopher A. Emigh, who finished fourth aboard HILARIOUS AFFAIR in the fourth race at Turfway Park on March 20, 2026, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Christopher A. Emigh is hereby fined two hundred fifty dollars (\$250.00) and suspended one Kentucky racing day, March 28, 2026.

Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
