HISA KENTUCKY STEWARDS RULING

KY. Ruling number: 26-027

Track: Turfway Park

Date: March 26, 2026

Jockey: Walter A. Rodriguez (HISA #P000018526)

After waiving his right to a hearing before the Board of Stewards, Walter A. Rodriguez, who finished first aboard CELTIC FLAME in the third race at Turfway Park on March 21, 2026, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (2nd offense in 180 days). Pursuant to HISA Rule 2282 (c)(1), Class 3, Walter A. Rodriguez is hereby fined one thousand dollars (\$1,000.00) and suspended two Kentucky racing days, April 8 and April 9, 2026.

Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
