HISA KENTUCKY STEWARDS RULING

KY. Ruling number: 26-030

Track: Keeneland

Date: April 11, 2026

Jockey: Irving Moncada (HISA #P000036614)

After waiving his right to a hearing before the Board of Stewards, Irving Moncada, who finished second aboard ROTISSERIE in the second race at Keeneland on April 9, 2026, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Irving Moncada is hereby fined two hundred fifty dollars (\$250.00) and suspended one Kentucky racing day, April 19, 2026.

Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
