HISA KENTUCKY STEWARDS RULING

KY. Ruling number: 26-032

Track: Keeneland

Date: April 12, 2026

Jockey: Luan Machado (HISA #P000005314)

After waiving his right to a hearing before the Board of Stewards, Luan Machado, who finished second aboard BEALE STREET BOY in the second race at Keeneland on April 11, 2026, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (3rd offense in 180 days). Pursuant to HISA Rule 2282 (c)(1), Class 3, Luan Machado is hereby fined seven hundred fifty dollars (\$750.00) and suspended three Kentucky racing days, April 22 through April 24, 2026 (inclusive).

Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
