HISA KENTUCKY STEWARDS RULING

Ky. Ruling number: 26-048

After waiving his right to a hearing before the Board of Stewards, Jaime A. Torres, who finished third aboard FROSTY FOR EVER in the second race at Churchill Downs on May 9, 2026, was found to have violated HISA Rule 2280 (b)(3) by striking his mount three consecutive times with the riding crop without allowing the horse a chance to respond. Pursuant to HISA Rule 8200 (b), Jaime A. Torres is hereby fined two hundred (\$200.00) dollars. Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
