HISA KENTUCKY STEWARDS RULING

KY. Ruling number: 26-056

Track: Churchill Downs

Date: May 30, 2026

Jockey: Sofia Vives (HISA #P000031991)

After waiving her right to a hearing before the Board of Stewards, Sofia Vives, who finished fifth aboard MURDOCK in the seventh race at Churchill Downs on May 28, 2026, was found to have violated HISA Rule 2280 (b)(2) by striking her mount seven times with the riding crop. Pursuant to HISA Rule 2282 (a)(1), Class 3, Sofia Vives is hereby fined five hundred dollars (\$500.00) and suspended one Kentucky racing day, June 3, 2026. Pursuant to HISA Rule 8200 (b), Sofia Vives is fined an additional two hundred dollars (\$200.00) for striking her mount three consecutive times with the riding crop without allowing the horse a chance to respond, in violation of HISA Rule 2280 (b)(3). Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
