HISA KENTUCKY STEWARDS RULING

After waiving his right to a hearing before the Board of Stewards, and pursuant to HISA Rule 2274 (a)(1), Jonathan Cedillo, who was in possession of an electrical device on association grounds on April 29, 2026, is hereby ineligible to be registered with HISA for a period of ten (10) years, through April 28, 2036, for violation of HISA Rule 2273 which states "No electrical, mechanical, or other device, which is purchased, designed, or used with the intent to increase or retard the speed of a Covered Horse, other than a riding crop, shall be possessed by anyone, or applied by anyone, to a Covered Horse at any time on Racetrack grounds."
