## **HISA KENTUCKY STEWARDS RULING**

**KY. Ruling number: 26-086**

**Track: Ellis Park**

**Date: August 8, 2026**

**Jockey: Francisco Arrieta (HISA #P000024687)**

After a hearing before the Board of Stewards, Francisco Arrieta, who finished second aboard CELTIC MO in the sixth race at Ellis Park on August 1, 2026, was found to have violated HISA Rule 2280 (b)(2) by striking his mount seven times with the riding crop (8<sup>th</sup> offense in 180 days). Pursuant to HISA Rule 2282 (c)(1), Class 3, Francisco Arrieta is hereby fined four thousand dollars (\$4,000.00) and suspended eight Kentucky racing days, August 29, August 30, September 3, September 5, September 6, September 7, September 9, and September 10, 2026.

Upon receipt of this ruling, it is required within thirty (30) days to pay any and all fines imposed to the Horseracing Integrity and Safety Authority.
