310 KAR 1:008 Section 3, subsection (4) and 810 KAR 1:018 Section 15, subsections (2) and (3) 810 KAR 1:012 Section 10, subsection (3) Upon notification from Industrial Laboratories and confirmed by the Analytical Forensic Testing Laboratory (AFTL), Sample ID: E707437 taken from "PRITI NOOR" who finished first in race five at the Western Kentucky State Fair @ Oak Grove on June 19th, 2024 contained 7-Carboxycannabidiol. After waiving his right to a formal hearing before the Board of Judges, Rodney DeBeck is hereby fined FIVE HUNDRED (\$500.00) DOLLARS and suspended THIRTY (30) DAYS. Due to mitigating circumstances (number of violations in relation to overall record), FIFTEEN (15) days are to be served from March 7, 2025 through and including March 21, 2025. The remaining FIFTEEN days are stayed. "Priti Noor" is disqualified and all purse money forfeited. During his suspension, Mr. DeBeck is denied the privileges of all facilities under the jurisdiction of the Kentucky Horse Racing and Gaming Corporation (KHRGC) HOUSE OF LOVE finished second placed first, SAFE LANDING finished third placed second, INDIANCREEK LEXY finished fourth placed third. FIYA finished fifth placed fourth and RELOAD finished sixth placed fifth. Upon receipt of this ruling, the licensee is required within thirty days to pay any and all fines and return all purse earnings to the KHRGC.
