NARRATIVE

CHRIS BROWN THE BOARD OF JUDGES DO HEREBY ISSUE A PENALTY OF \$500.00 (FIVE HUNDRED DOLLARS) AND WILL PLACE MR. CHRIS BROWN ON 12 MONTH PROBATION FOR ANY FUTURE VIOLATIONS OF NATURE COULD RESULT IN ESCALATED PENALTIES.
