## Narrative

Mr. Steven T Fortune is the designated trainer for #1 Dynamic Desire who raced on 3/24/2025 at Oak Grove in the 7<sup>th</sup> Race. #1 Dynamic Desire finished 1<sup>st</sup> and was sent to the State Test Barn for Post Race Sampling. After Post Race analysis of Sample #E622209 was sent to Industrial Laboratories they have confirmed an overage of Flunixin at a level of 14.3ng/mL which is above the threshold of 5ng/mL as set by the KHRGC in 810 KAR 8:030. Due to this violation #1 Dynamic Desire is hereby disqualified and placed 10<sup>th</sup>. All purse money of \$5,000.00 (Five Thousand Dollars) must be returned and ordered to be redistributed. Mr. Steven T Fortune has no previous violations of any Class C Medication in the previous 365 days. Mr. Steven T Fortune is hereby fined a sum of \$1,000.00 (One Thousand Dollars).




