Total purse money of \$6,000.00 (Six Thousand Dollars) must be returned and ordered to be redistributed. This is Mr. Tony Dinges' 1st Violation in 365 Days for TCO2. No Horses may be transferred to another trainer or sold without the approval of the KHRGC Judges. Due to mitigating circumstances the Suspension has been reduced.
