Due to being ejected by Oak Grove Mr. Brandon Bates license in the Commonwealth of Kentucky is hereby revoked and he will only be eligible to apply for a license in the Commonwealth of Kentucky once he has been removed from the “No Trespass List” at Oak Grove.
