### **Narrative**

Mr. Randy Crisler was the Driver of #9 Just A Start who was in 8<sup>th</sup> Race at Oak Grove on 4/28/2025. Mr. Crisler did crowd #1 Frozen Shark in the last turn violating 810 KAR 5:070 Section 1 – 5 causing #1 Frozen Shark to use the Safety Lane while finishing the race causing placings. #9 Just A Start was 4<sup>th</sup> placed 10<sup>th</sup> due to the interference and all others were placed accordingly. This is Mr. Crisler's 1<sup>st</sup> interference violation in the Commonwealth of Kentucky in the Calendar Year.
