### **Narrative**

Mr. Jamaal Denson was the listed driver of #6 Three Card who was in the 13<sup>th</sup> Race at Oak Grove on 6/17/2025. Mr. Denson allowed his horse to change course in the stretch causing interference to #4 Precious Macey and #7 Kissinbythebeaches requiring #6 Three Card to be 1<sup>st</sup> placed 5<sup>th</sup> behind impeded horses violating 810 KAR 5:070 Section 1 – 10.
