Narrative

Mr. Austin Fowler is a licensed groom under KHRGC Jurisdiction in the Commonwealth of Kentucky. Following up on a concern about Mr. Fowler being suspected of being intoxicated while in the paddock at Oak Grove on 6/30/2025 Presiding Judge Casey Larson instructed KHRGC Investigator Bryan Tolson to locate and administer a P.B.T. test to Mr. Fowler. Investigator Tolson had Mr. Fowler submit to a P.B.T. at 1:16 PM in the Paddock Office at Oak Grove resulting in a positive test of 0.214 BAC. This is a clear and concerning violation of 810 KAR 2:030 Section 3 – 1 – A by being over the allowed limit of 0.05 BAC. Mr. Fowler was removed from the paddock and his license was detained by Investigator Tolson and Mr. Fowler was instructed to meet with the Board of Judges at 11:00 AM the following day in their office for a hearing. After having a hearing with Mr. Fowler at 11:00 AM on 7/1/2025 and to the maintain integrity and safety of horse racing and to protect all other licensees the Board of Judges have agreed Mr. Fowler will be fully suspended as stated in 810 KAR 2:030 Section 4 – 1 – A for a period of fifteen (15) days from 7/1/2025 thru and including 7/15/2025 from any association or racetrack under the jurisdiction of the KHRGC. After said suspension Mr. Fowler will be subject to testing at the discretion of the Presiding Judge anytime on a licensed grounds of any facility and any further violations will be subject to further escalating penalties.
