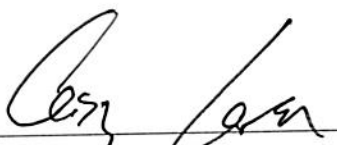

Ms. Whisenant is hereby issued a full suspension of her 2026 license from 8/24/2026 through 12/31/2026 for a total of 129 days. Any further applications from Ms. Whisenant will be subject to review by the Board of Judges.
