#8 "Duplantis" (Edgar Morales) finished sixth and required the assistance of the KHRC veterinarian and the horse ambulance. It was later reported that the horse had returned lame and was placed on the See State Vet list.

6th RACE #5 "Chicago's Gray" (Florent Geroux) stumbled at the start and unseated his rider. The horse ran behind the field and was caught without incident. The rider escaped serious injury.


7th RACE Voided 3 claims - insufficient funds

8th RACE CLEAR


9th RACE A Stewards Inquiry was posted shortly after the start when #13 "Cherokee Song" broke extremely awkwardly and trailed the field. After reviewing the replay of the start, interviewing the starter and jockey Rolando Aragon, the stewards determined that the assistant starter inadvertently pulled the horse's head toward him at the break while attempting to dislodge a lead up strap that had been placed on the horse. Because the horse was precluded from obtaining a fair start, #13 "Cherokee Song" was declared a nonstarter by the stewards. The mutuels department made the proper refunds.

10th RACE #2 "Mariah's Princess" BLED, was eased, and required the assistance of the KHRC veterinarians and the horse ambulance. The filly was placed on the See State Vet list.

11th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.
